PUBLISHING LAND & PROPERTY SERVICES (LPS) / ORDNANCE SURVEY OF NORTHERN IRELAND® (OSNI®) BRANDED INTELLECTUAL PROPERTY (IP) ON THE INTERNET Guidance Notes

Context

- Land & Property Services produces all OSNI branded IP. To publish this on the Internet you must have LPS prior written permission.
- You may only publish Digital data in raster format on the Internet.
- For permission to publish please complete the application form Publishing 1A.
- If permission is granted your permit will last for 12 months from the date of issue. This must be renewed annually thereafter, if you wish to continue to publish.

Charges

- The minimum charge for issuing a 12 month Internet permit is £57.50.
- All charges are subject to the prevailing rate of Value Added Tax.
- These charges will be revised from 1st April each year.

We will agree the exact format with you and we are prepared to be flexible as to how the following is displayed.

1. Publishing a fixed image based on a scan of a paper map or Air Photograph.

- Original paper image scan not to exceed 12cms x 12cms.
- An application allows up to ten images to be displayed based upon the scan size of 12cms x 12cms.
- Any additional image thereafter based upon the scan size of 12cms x 12cms will be charged at £5.75.
- You may allow the printing of screen dumps provided that you do not charge for these. If you wish to charge please see **7** below.

2. Publishing images based on a scan of a paper map or Air Photograph exceeding 12cms x 12cms.

- We will charge you a comparable licence fee and royalties as stated in 4 or 5 or 6 below depending on your usage.

PUBLISHING USING DIGITAL DATA

3. Publishing Orthophotography

Please note: You cannot publish Orthophotography without a current digital Orthophotography licence.

- For fixed images not exceeding 12cms x 12cms the conditions and charges for publishing a fixed image based on a scan of a paper map or Air Photograph in 1 above will apply.

You may allow the printing of screen dumps, provided that you do not charge for these. If you wish to charge please see **7** below.

- For fixed images exceeding 12cms x 12cms the publishing Royalties will be £57.50 per image.

You may allow the printing of screen dumps, provided that you do not charge for these. If you wish to charge please see **7** below.

- For Pan and Zoom view only the publishing Royalties will be 1% of the original licence fee with a minimum charge of £57.50.

Note: It is your responsibility to ensure that all download / or printing (including via a screen dump) is disabled.

- For Pan and Zoom with screen dumps the publishing Royalties will be 5% of the original licence fee with a minimum charge of £57.50.

You may allow the printing of screen dumps, provided that you do not charge for these. If you wish to charge please see **7** below.

4. Fixed images

- If you have licensed raster IP, or converted licensed vector IP to raster format the publishing Royalties for fixed images not exceeding 12cms x 12cms the conditions and charges for publishing a fixed image based on a scan of a paper map or Air Photograph in 1 above will apply.
- If you have licensed raster IP, or converted licensed vector IP to raster format, the publishing Royalties for images exceeding 12cms x 12cms will be £57.50 per image.
- If you have not licensed LPS IP, you will be charged:
 - a comparable Licence fee plus
 - £57.50 per image for images exceeding 12cms x 12cms
- You may allow the printing of screen dumps, provided that you do not charge for these. If you wish to charge please see **7** below.

5. Pan and Zoom view only

It is your responsibility to ensure that all download / or printing (including via a screen dump) is disabled.

- If you have licensed raster IP or converted licensed vector IP to raster format the publishing Royalties will be 1% of the original licence fee.
- If you have not licensed LPS IP, you will be charged:
 - a comparable Licence fee
 - plus 1% Royalties

6. Pan and Zoom with screen dumps

- If you have licensed raster IP or converted vector IP to raster format the publishing Royalties will be 5% of the original licence fee.
- If you have not licensed LPS IP, you will be charged:
 - a comparable Licence fee
 - plus 5% Royalties
- You may allow the printing of screen dumps, provided that you do not charge for these. If you wish to charge please see **7** below.

7. If you wish to allow downloads of LPS digital IP from your Internet site you are in effect distributing LPS IP and you should contact LPS on 028 9025 1713 who will discuss with you the appropriate terms and conditions to be captured in a Distribution and Licensing Agreement with LPS. If you wish to charge for screen dumps, or any uses outside of the terms and conditions contained within this document, please discuss with LPS Channel Development.
